

# VM40 & VM85 Ice Vending Machine Fee Explanation

#### **Introduction**

The Leer VM40 & VM85 Ice Vending Machines require two monthly fees - Vending Service and Payment & Credit Card Processing Fees.

### **Vending Service Fees**

The Vending Service Fee covers the management of vending technology, remote portals, hosting, encryption, updates to software, and cellular signal.

The vending software company, VendNovation, charges a fee of \$25 per month, per machine. This charge will be collected by Leer Inc. and we will settle all open invoices on your behalf.

### **Banking & Credit Card Processing Fees**

The Banking & Credit Card Processing Fees cover the management of processing software, clearing of transactions, monetary deposits into your account, and industry-standard credit card processing fees.

The Banking & Credit Card Processing Fee contains two payment structures. The following charts highlights the payment structures based on the quantity of Ice Vending Machines.
